TERMS AND CONDITIONS:-

- Their appointments in the Food Department would be purely temporary and their services can be terminated at one month's notice without any reasons being assigned at any time irrespective of the fact that they are holding the post other than the one to which they were originally recruited or on the payment of one month's salary in lieu of the notice.
- The benevolent fund will be deducted and G.P. Fund as required under the relevant rules.
- They have to join duty at their own expenses.
- They are a bonafide resident of FR/FATA/ Khyber Pakhtunkhwa, for which they would supply the Original Domicile Certificate and National Identity Card.
- In case they wish to resign at any time, month's pay may be forfeited.
- Their Services will be subject to medical fitness for Government Service for which they should produce Health and Age Certificates from the concerned Medical Superintendent.
- They will be governed by the Rules and Regulation issued by the Government from time to time for such category of Government Servants to which they belongs.
