MINUTES OF THE MEETING OF DEPARTMENTAL PROMOTION COMMITTEE HELD ON 18-12-2015

A meeting of the Departmental Promotion Committee of Food Department was held on 18-12-2015 under the Chairmanship of the Secretary Food Khyber Pakhtunkhwa in his office

The Secretary Food Department welcomed the participants and asked the Deputy Secretary Food to explain the cases under consideration. The Deputy Secretary Food informed the forum that there are 27 sanctioned posts of District Food Controller (BPS-16) in Food Department Khyber Pakhtunkhwa out of which 03 posts of District Food Controller (BPS-16) have become vacant due to the following reason.

- i. One post of District Food Controller has been newly created for District Turghar.
- ii. Mr. Ajab Khan DFC Swat retired from service on 12-08-2015
- iii. Appointment of Mr. Faridullah khan Afridi DFC as ADF BS-17 on acting charge basis.

He further elaborated that according to the appointment / recruitment Rules 1981, under S.No. 09 the following method has been laid down for filling the post of District Food Controller (BPS-16).

- a. 25% by initial recruitment, and
- b. 75% by selection on merit with particular reference to fitness for higher responsibilities from amongst AFCs with at least 05 years Service as such.



It was further explained that one out of the vacant posts falls in the initial recruitment which is under process in Public Service Commission and 02 posts are to be filled on promotion as per above rules.

The representative of the Establishment Department pointed that one post of the District Food Controller will be filled on regular basis as clear vacancy exists for him but the second official on panel will be appointed.

A panel of four (04) Assistant Food Controller (BS-14) was presented before the forum a/w documents complete in all respect as per instructions of Establishment Department for regular promotion/appointment on acting charge basis against the 02 available posts. All the officials in panel have completed minimum 05 years service in the present position as required under the rules.


After going through record the committee made the following recommendation.

1.	Mr. Sher Afzal	AFC (Bannu)	The committee recommended to promote him to the post of DFC/S&EO/Rationing Controller (BS-16) on regular basis. He will be on probation for the period of one year as per rules.
2.	Mr. Tajbar Khan	S&EO, NRC Azakhel, AFC, holding post of DFC at Dir upper in his own pay and scale	Committee recommended him for appointment as DFC/S&EO/Rationing Controller on acting charge basis in terms of Para-2 of policy instructions dated 13-01-1999.
