2. Tenders are required to be submitted to office of the undersigned along with 2% earnest money in the shape of call deposit/bank draft.
3. Quoted rates must be inclusive of all taxes/duties/transportation cost.
4. All applicable taxes shall be deducted as per Pakistani Taxation Law.
5. All items should be supplied /installed / commissioning as per supply order; in case of failure call deposit/performance bond shall stand forfeited.
6. The provisions in the Instructions to Bidders and in the General Conditions of Contract are in strict compliance with the provisions of the Khyber Pakhtunkhwa Public Procurement Act 2012 and its Rules 2014.
7. Only the firms/authorized dealers registered with Sales Tax Department should submit their tenders.
8. An affidavit regarding provision of original / genuine items will be submitted by the successful bidder on the stamp paper.
9. It will be a single stage one envelope procedure.
10. The bidders shall provide on a stamp paper an Affidavit stating that the proponent has never been blacklisted by any government/semi-government organizations (procuring entity) under the administrative control of the federal/provincial governments.

Tenders completed in all respect and clearly marked with "Tender for IT & Office Equipment" must reach to hall # 230, 1st Floor, Benevolent Fund building, Peshawar Saddar on or before 28th September, 017 by 1400 hours which will be opened on the same day at 1430 hours in the presence of bidders/representatives who wish to attend.
