No. PA/Khyber Pakhtunkhwa/Bills 151/2018/4829.—The Khyber Pakhtunkhwa Public Service Commission (Amendment) Bill, 2018 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 19th February, 2018 and assented to by the Governor of the Khyber Pakhtunkhwa on 28th February, 2018 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA PUBLIC SERVICE COMMISSION (AMENDMENT) ACT, 2018

(KHYBER PAKHTUNKHWA ACT NO. VII OF 2018)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 5th March, 2018).

AN ACT

*further to amend the Khyber Pakhtunkhwa
Public Service Commission Ordinance, 1978*

WHEREAS, it is expedient further to amend the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978 (Khyber Pakhtunkhwa Ordinance No. XI of 1978), for the purposes hereinafter appearing;

It is hereby enacted as follows:

- 1. Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Public Service Commission (Amendment) Act, 2018.

(2) It shall come into force at once

2. **Amendment of section 7 of Ordinance No. XI of 1978.**--- In the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978 (Khyber Pakhtunkhwa Ordinance No. XI of 1978), in section 7,-

(a) in sub-section (1),-

(i) in clause (a), in sub-clause (ii), for the figures and word " 11 to", the figures and word " 14 and" shall be substituted;

(ii) after clause (a), the following shall be inserted, namely:
"Explanation.—In this clause, recruitment means initial appointment other than by promotion or transfer.";

(iii) after clause (b), the "Explanation" shall be deleted and the following new clauses shall be added, namely:

"(c) to hold such other tests and examinations for promotion, selection on merit or initial appointment as the case may be, for such posts as Government may determine from time to time.

(d) to act on any other matter which Government may refer to the Commission, from time to time."; and

(b) in sub-section (2), in clause (iv), after the words "the posts of", the words "Computer Operator, Assistant, Junior Scale Stenographer and "shall be inserted.
