- All applicable Taxes will be deducted as per KPPRA Rules from the supplier.
- Only those bidders will be eligible for evaluation who are at active tax payer list of FBR.
- Tender incomplete and received after due date will not be entertained /considered.
- The competent authority reserves the right to accept/reject, all or one tender (s) on cogent reasons under KPPRA Rules.
- Single stage one envelope method will be used.
- The bidders are required to produce sample before opening of bids.
- The bidders must be free from courts.
- If at any stage concealment/distortion of facts is detected, it would be sufficient cause to reject the qualification.
- Attested photocopies of Tax returns for last 02 years.
