NOTIFICATION

No. E&A/LD/5-14/2017/

In pursuance of the Establishment & Administration Department (Regulation Wing) Notification No. SO (O&M)/E&AD/2-15/2013 dated 09.01.2019 the Competent Authority has been pleased to notify the establishment of Directorate General of Law & Human Rights with immediate effect, with the following TORs.

- I. to perform all the functions as provided in the Khyber Pakhtunkhwa Promotion, Protection and Enforcement of Human Rights Act, 2014;
- II. responsible for the general supervision, control and administration of the staff of the Directorate General and the District Attorneys;
- III. monitor the activities and performance of the District Attorneys to ensure that District Attorneys shall safeguard the interest of Government in Civil Courts of Law;
- IV. issue directions from time to time to the District Attorneys in relation to conducting of Government civil litigation in the Civil Courts of Law;
- V. render timely advice to the Administrative Departments if any action/advice is required from the Directorate of legal in a case / matter on passing of stay /interim /final order.
- VI. Convey immediately recommendations about appeal / revision / review or otherwise on the orders passed by the Hon'able Courts adverse to the interest of Provincial Government Department.
- VII. require the District Attorneys to submit monthly progress report of civil cases by or against Government to the Director General; and
- VIII. submit performance report on fortnightly basis to Secretary to Government of Khyber Pakhtunkhwa Law, Parliamentary Affairs and Human Rights Department on the performance of the District Attorneys and Court cases to the Secretary to Government, Law, Parliamentary Affairs and Human Rights Department.
- IX. conduct inspections of all the offices of the District Attorney from time to time.
- X. direct the District Attorneys to maintain record and registers; and
- XI. perform any other function as assigned to him by Secretary to Government, Law, Parliamentary Affairs and Human Rights Department.
