In exercise of powers conferred by sub-rule (2) of rule 3 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989, the Law, Parliamentary Affairs and Human Rights Department, in consultation with the Establishment and the Finance Departments, hereby directs that in the Khyber Pakhtunkhwa Office of Advocate General (Recruitment and Appointment) Rules, 1981, the following further amendments shall be made, namely:

**AMENDMENTS**

In the Appendix,-

- (a) the existing serial No. 1 shall be re-numbered as 1(b) and before Serial No. 1(b), as so renumbered, the following new entries shall be inserted in the respective columns, namely:

"1	Senior Administrative Officer	---	---	By promotion, on the basis of seniority-cum-fitness, from amongst the Administrative Officers and Budget and Accounts Officers with at least five (05) year service as such.  <b>Note:</b> A joint seniority of Administrative Officers and Budget and Accounts Officers shall be maintained for the purpose of promotion.
1(a)	Reference & Research Officer	---	---	By promotion, on the basis of seniority-cum-fitness, from amongst the Librarians and Research Officers with at least five (05) year service as such.  <b>Note:</b> A joint seniority of Librarians and Research Officers shall be maintained for the purpose of promotion.

- (b) after Serial No. 2, the following new entries shall be inserted in the respective Columns, namely:

"2(a)	Research Officer	LLB degree with five (05) years experience as a practicing lawyer of the High Court.	25-35 year.	<p>1. Fifty percent (50%) by promotion, on the basis of seniority-cum- fitness from amongst the Library Assistants, Assistants and Senior scale Stenographers, having LLB degree with at least five (05) year service, as such; and</p> <p>2. fifty percent (50%) by initial recruitment.</p> <p><b>Note:</b> A joint seniority of Library Assistants, Assistants and Senior Scale Stenographers shall be maintained for the purpose of promotion.</p>
